

Hack the Future and Circuit Launch
Release of Liability and Assumption of Risk Agreement

This is a release and a binding agreement. Read it carefully before signing. This release essentially states that I know that I will be engaging in activities related to Hack the Future ____ (*Print Event Number*) at Circuit Launch, and I am doing so voluntarily. As a result of the inherent risks in this activity, I know I may be harmed, injured, or die and that my belongings may be lost, misplaced, damaged, or stolen. If any of these occur, I understand that I cannot make a claim, sue, or expect either Circuit Launch or Hack the Future, their owners, affiliates, officers, agents, employees, and/or associates (hereinafter referred to as "Circuit Launch" and "Hack the Future") to be legally responsible or pay for any damages.

ACKNOWLEDGEMENT AND ACCEPTANCE OF RISKS: I, the undersigned, hereby acknowledge that I have voluntarily chose to participate in Hack the Future activity. Certain risks are inherent in any recreational activity and cannot be eliminated, altered, or controlled and these risks contribute to the unique character of the activity can also be the cause of injury, illness, death or damages.

I acknowledge and willingly assume all risks and hazards in the Hack the Future activity from the beginning to the end of the activity, including but not limited to: (1) injury, (2) illness, (3) damage, or (4) death to myself or others. I further understand and acknowledge that the above list is not complete or exhaustive, and that other risks, known and unknown, anticipated or unanticipated, may also exist and result in injury, illness, disease, death, or damage. **My participation in this activity is purely voluntary and I elect to do so at my own risk.**

RELEASE: In consideration for Hack the Future allowing me to participate in this activity, I voluntarily release, discharge, and hold harmless Hack the Future and Circuit Launch for any claims of liability arising out of their negligence, fault, recklessness, or any other act or omission which causes the undersigned illness, injury, death, and damages in any nature in any way connected with my participation in this activity. I also expressly agree to release and discharge Hack the Future and Circuit Launch from any act of omission or negligence in rendering or failing to render any type of medical services in event of an emergency. **In signing this document, I fully recognize and understand that if I (or any minor on whose behalf I am signing this release) am hurt, die, or my property is lost or damaged, I am giving up my right to make a claim or file a lawsuit against Hack the Future or Circuit Launch, even if they negligently or by some other act or omission cause the injury or damage.**

I further agree, to hold harmless, defend, and indemnify, Hack the Future and Circuit Launch from all defense costs, including attorney's fees incurred in connection with claims for bodily injury, wrongful death, or property damage sustained by any minor under 18 years of age on whose behalf I am signing, or which I may have caused to spectators or other third parties, whether negligent or not, in the course of my participation in this activity.

As a parent or legal guardian of a participant under 18 years of age, I have read and voluntarily agree that said minor may participate in this Hack the Future activity, and I sign this release on their behalf and on the behalf of the minor's parents and/or legal guardians. In addition, I give Hack the Future permission to treat said minor in case of illness, injury, emergency, or accident. Should emergency medical services become necessary, for the undersigned participant or minor, the expenses are the sole responsibility of the participant and not of Hack the Future or Circuit Launch. I hereby agree that Hack the Future may use film, voice, or photographic records of these activities for promotional or commercial purposes.

I HAVE READ THIS DOCUMENT IN ITS ENTIRETY. I UNDERSTAND THAT I AM ASSUMING ALL THE RISKS INHERENT IN THIS HACK THE FUTURE ACTIVITY. I UNDERSTAND THAT IT IS A RELEASE OF ANY AND ALL CLAIMS. I UNDERSTAND THAT THIS IS THE ENTIRE AGREEMENT BETWEEN THE UNDERSIGNED AND HACK THE FUTURE / CIRCUIT LAUNCH, OWNERS, AFFILIATES, OFFICERS, AGENTS, AND EMPLOYEES AND IT CANNOT BE MODIFIED OR CHANGED IN ANY WAY BY REPRESENTATIVES OR STATEMENTS BY HACK THE FUTURE / CIRCUIT LAUNCH OR BY THE UNDERSIGNED.
